The Harrisburg School District has a new dress code for all students in grades kindergarten through twelve beginning August 1, 2011.

Boys will wear (see examples on reverse side of letter)

Pants	Tan, dark blue, gray or black	With belt buckled on the waist
Knee-length shorts-ONLY on first day of school to October 15 and from April 15 to last day of school	Tan, dark blue, gray or black	With belt buckled on the waist
Shirts with collar	Solid color	Short or long sleeves
Sweater with front zipper or button opening	Solid color	

Girls will wear (see examples on reverse side of letter)

Pants	Tan, dark blue, gray or black	With belt buckled on the waist
Skirts-must be knee-length to ankle length	Tan, dark blue, gray or black	
Knee-length shorts-ONLY on first day of school to October 15 and from April 15 to last day of school	Tan, dark blue, gray or black	With belt buckled on the waist
Shirts with collar	Solid color	Short or long sleeves
Sweater with front zipper or button opening	Solid color

Parents, school staff, and administrators will make sure all students follow the dress code. A dress code violation will result in a parent/guardian contact. Parents/guardians of students who wear clothing for religious purposes **must** notify your child's school office.
